Minimum Criteria to Apply

• Has been nominated by their advising team. The advising team for each company can nominate one member of their team for this award.

How to Apply

- Complete the application form below. This is a fillable form. For this form to work properly, you need to download the form and save it to your desktop first, then edit the form and save it again. Please type your responses using a computer, do not print and handwrite your submission. You will electronically sign this form at the bottom.
- After completing the student sections of the form, have one of your advisors fill out the advisor section on the same form. They will read your answers to ensure they are complete and accurate and then will sign off on your application.
- **Application Tip:** Make sure you start writing your application well in advance of the deadline to account for editing, reviewing, advisor responses and any unforeseen circumstances. Try not to submit your answers last minute!
- *NEW* VIDEO REQUIREMENT In place of Student Interview Night this year, we are adding a video requirement to the JA Company Program Award Nomination Submissions. All students must submit a video along with their written submission when submitting online.
- The video requirements are as follows:
- -Video should be no longer than 2 minutes in length outlining why you deserve to win the award you are applying for
- -In your video, please ensure that you back your answer up with concrete examples
- -No PPTs or digital visuals are allowed, but products are allowed in the video.
- -Presentation skills & delivery will be judged, but not the overall video production quality. We are not looking for a professionally shot video however, it is very important that the audio be heard clearly for judges to understand your message
- -A video can be filmed on any device smart phone, laptop, webcam, etc.
- -Do not include footage of anyone who hasn't given consent to appear in the film or use copyrighted music/images
- After your advisor has signed off on your form, submit in PDF format (save file as Award Name Student Name i.e President of the Year Lesley Tulipano) along with your video at:
